



ORDINANCE NO. 07-706

***An Ordinance Amending the Code of Ordinances,
Chapter 5 Fire Prevention & Protection,
Article 1 In General, Section 5.1 Adoption***

The Town Council of the Town of Carolina Beach hereby amends the Carolina Beach Code of Ordinances, Chapter 5 Fire Prevention & Protection, Article 1 In General, Section 5.1 Adoption, as follows:

The Town Council of the Town of Carolina Beach hereby amends Chapter 5 Fire Prevention and Protection, Article 1 In General, by deleting Section 5 1 Adoption, and replacing it with the **2006** edition of the International Fire Code including Appendix Chapters **B-H** and the North Carolina amendments, regulating and governing the safeguarding of life and property from fire and explosion hazards arising from the storage, handling and use of hazardous substances, materials and devices, and from conditions hazardous to life or property in the occupancy of buildings and premises in the Town of Carolina Beach; providing for the issuance of permits for hazardous uses or operations;


The Town Council of the Town of Carolina Beach does ordain as follows:

That a certain document, three (3) copies of which are on file in the office of the Fire Chief of the Town of Carolina Beach, being marked and designated as the International Fire Code, including Appendix Chapters **B-H** and the North Carolina amendments, as published by the International Code Council, be and is hereby adopted as the code of the Town of Carolina Beach for regulating and governing the safeguarding of life and property from fire and explosion hazards arising form the storage, handling and use of hazardous substances, materials and devices, and from conditions hazardous to life or property in the occupancy of buildings and premises in the Town of Carolina Beach and providing for the issuance of permits for hazardous uses or operations; and each and all of the regulations, provisions, conditions and terms of such International Fire Code **2006** edition, published by the International Code Council, on file in the office of the Fire Chief as hereby referred to, adopted and made a part hereof as it fully set in this ordinance.

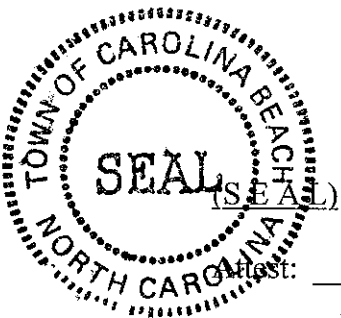
That Section 5-1 Adoption, of the Code of Ordinances, of the Town of Carolina Beach, and all other ordinances or parts of ordinances in conflict herewith are hereby repealed and replaced as described herein.


That if any section, subsection, sentence, clause or phrase of this ordinance, if for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance. The Town Council hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

That is ordinance and rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effective on August 14, 2007.
